Terms and Conditions

Minimum age for shareholding membership is 16. Membership is per person or activity club. All members have one vote. Membership is effected by taking up 100 or more £1 shares (maximum 20,000). Interest is paid annually on shareholdings of £25 and above, as recommended by the directors and voted at the annual general meeting. As a member you are a shareholder of HF Holidays Ltd. If the Society is unable to meet its debts and other liabilities, you will lose the whole amount held in shares (known as risk capital). The Financial Services Compensation Scheme, which applies to bank and building society accounts and some investments, does not apply to your share account. The Society, unlike banks, building societies and investment firms, is not authorised and supervised by the Financial Services Authority (although it may be registered by it). Therefore you cannot claim compensation under this Scheme in the event of the Society not being able to pay out your share capital. Interest is accrued to your shareholdings, unless you have already reached the maximum permissible, in which case, you will be paid the excess balance. Interest is applied gross and is taxable. It is the shareholder's responsibility to declare these earnings to HMRC. Withdrawal of shares is permissible, subject to the Rules of the Society. You cannot sell or transfer your shares to another person within your lifetime. A copy of the Rules is included in the new members welcome pack.
